The successful candidate should have knowledge of AWWA standards including water metering standards, EPA Public Water Supply Regulations, City and Illinois State plumbing codes and regulations, water meter reading techniques and systems, and OSHA standards as they apply to confined space entry. A state of Illinois Class D Drinking Water Operator certificate of competency must be obtained within one year after appointment. The individual must also possess a valid State of Illinois driver's license and have a high school diploma or equivalent. Residency within the corporate limits of Macon County or within fifteen (15) miles of the corporate limits of the City of Decatur within twelve (12) months after appointment is required. The salary range for this position is: \$33,400 - \$43,350 annually, with growth potential to \$53,300 DOQ.
